

Please submit your application in one package and email to Ilm@uconn.edu (Subject: Your Name-Application). Your application should contain the following pieces. Please read the directions carefully prior to submitting your application.

- 1. Complete, sign, and date this form.
- 2. Please enclose a copy of your **resume or CV** that is current up to the date of your application. It should include present and previous employment, name of employer, professional experience, dates of work and telephone number. Indicate any jurisdictions where you qualify to practice, and any Bar Association memberships. If not employed, indicate current full-time activity. Please indicate relevant internship or volunteer experience.
- 3. Please include a **personal statement** (typed) approximately 750 words in length about your reasons for seeking the LL.M. degree and the goals you seek to achieve. In addition, you may wish to draw the attention of the Admissions Committee to a particular part of your record or to particular achievements and qualities not otherwise revealed by this application.
- 4. Please include a **legal writing sample**, which may be a copy of a legal paper or publication you have written. Alternatively, you may include an essay (at least 1000 words, approximately 5-8 pages) on a legal topic of interest to you.
- 5. Provide **letters of recommendation from two individuals** who are either present or former law professors or employment supervisors.
- 6. Provide an official transcript from your first law degree institution in English and the original language.
- 7. If English is not your native language, or if you do not qualify for any other English language proficiency waiver, please submit your official **TOEFL/IELTS test score**. The University of Connecticut School of Law TOEFL/IELTS code is 3915.


